Subject: Notice of 15-Day Revisions to the CEQA Guidelines

On January 26, 2018, the California Natural Resources Agency ("Agency") published a Notice of Proposed Rulemaking to update the Guidelines Implementing the California Environmental Quality Act ("CEQA Guidelines"). The Agency conducted public hearings on the proposal on March 14 and March 15, 2018. Revisions to the originally-proposed changes to the Guidelines ("15-day language") are now available for public comment. The text of the 15-day language, notice, and related

documents are available on the Agency's website at: <http://resources.ca.gov/ceqa/>. Comments regarding the 15-day language must be submitted to the Agency by 5:00pm on July 20, 2018.
