The California Natural Resources Agency posted a copy of the plan on its Web site (http://resources.ca.gov/ocean/CIAP.html) and noticed the availability of the plan for comment through the Agency's e-mail listserv, which comprises more than 4,000 members. Section IV of the plan provides additional detail on the extensive efforts the Natural Resources Agency undertook to provide information to the public, eligible coastal counties and numerous other entities regarding the CIAP and to involve those parties in the development of the plan.

Subject: State Coastal Impact Assistance Program Plan Workshops

In November 2005, I was designated by Governor Arnold Schwarzenegger as the lead for implementing the federal Coastal Impact Assistance Program (CIAP) in California. This program will provide federal grant funds from offshore oil and gas revenues to the state and seventeen eligible counties over the next four years. This program will be administered by the Minerals Management Service (MMS) and I am working closely with them. Authorized uses of these grant funds include, but are not limit to the conservation, protection, or restoration of coastal areas, including wetlands; mitigation of damage to fish, wildlife, or natural resources resulting from activities in the Outer Continental Shelf (OCS); planning assistance and the administrative costs of complying with the federal CIAP legislation; implementation of a federally-approved marine, coastal, or comprehensive conservation management plan; and mitigation of the impact of OCS activities through funding of onshore infrastructure projects and public services.

The MMS has informed my office that it will release the official CIAP funding allocation figures to the state and counties in April of this year. In anticipation of this event, the Resources Agency will hold two public workshops so that it may begin working with the seventeen eligible counties in compiling the state's CIAP plan pursuant to Section 31 of the federal Energy Policy Act of 2005. The CIAP plan will describe how the state and the 17 eligible counties propose to spend their allocations of grant funds under the CIAP. The plan will be subject to approval by the Governor and the Director of the MMS before any CIAP grant funds are dispersed. The Resources Agency's target for submitting the state's CIAP plan to the MMS is August 2007.
