The Commission will receive a brief update on the development of a report on the Commission's activities, presentations on inundation maps and new atmospheric river research, and an update on Oroville Dam facility winter operations. There also will be time for public input. The Citizens Advisory Commission is a forum for questions and feedback from the communities surrounding Oroville Dam.
