The Tribe has been conducting fuels reduction on the USFS Feather Falls Trailhead for several years and now the Tribe has entered into an historic Co-Stewardship Agreement with the BLM. In 2023, the Tribe purchased approximately 3000 acres in the Feather Falls area, however, it is currently checkerboarded. This project would fund the planning and acquisition of remaining parcels in the ancestral landscape and provide funding for permitting to restore the land to the status that it was in prior to its dispossession from the Tribe.

Project Description: Phase III Implementation Project of the Supply Creek Restoration Project would continue downstream restoration of Supply Creek tributary to the Trinity River on the Hoopa Valley Indian Reservation (HVIR) in Hoopa, CA. A levee and channelization have disconnected the Supply Creek from its former floodplain, restricting salmonid access to key habitat. Additionally, antiquated infrastructure, such as a septic system and leach field, threatens water quality. The primary objectives of Phase III implementation are to enhance habitat conditions by septic tank and leach field removal, and channel lengthening and off channel habitat creation through levee setback, and road setback/reconstruction. New mainstem, off-channel, and floodplain restoration in Phase III would augment what was achieved in Phase I and II expanding of high-quality salmonid habitat on Supply Creek and will support Phase III condition improvements.
