9. **Action Item: Proposed Del Puerto Reservoir Project**

*The 2016 Water Infrastructure Improvements for the Nation (WIIN) Act provides federal funding for water infrastructure. Section 4007, related to water storage, requires the Commission to determine that California storage projects seeking funding from the WIIN Act are consistent with Proposition 1, the California Water Quality, Supply, and Infrastructure Improvement Act, approved November 4, 2014. The Del*

*Puerto Water District and the San Joaquin River Exchange Contractors Water Authority are jointly applying for WIIN Act funds to plan for an 85,000 acre-foot reservoir located on Del Puerto Creek west of Patterson, California. The reservoir would increase south of Delta off-stream storage for water supply and environmental benefits. The project proponents will present information to the Commission about how the proposed Del Puerto Reservoir project is consistent with Proposition 1. The Commission may determine the project is consistent with Proposition 1, or may take another action as the Commission determines, in its discretion.*

**10. County Drought and Water Shortage Contingency Planning**

*DWR Staff will brief the Commission on its efforts (as required by AB 1688) to develop recommendations and guidance relating to countywide drought and water shortage contingency plans by January 1, 2020.*

**11. Oroville Recovery Effort**

*State Water Project staff will brief the Commission on progress with repairing the Oroville spillways and the comprehensive needs assessment at the Oroville complex.*
