11. Informational Update on Dam Safety Regulations

Department of Water Resources (DWR) staff will present an overview of proposed changes to dam safety regulations necessary to align with recent changes to the Water Code and to update and clarify current regulatory practices.

12. Salton Sea Management Program Update

Staff from the California Natural Resources Agency and DWR will present an overview of the Salton Sea Management Program's restoration actions, the Salton Sea's nexus to the Colorado River, the State's 10-Year Restoration Plan, and recent federal Inflation Reduction Act investments to accelerate restoration implementation.

Staff from DWR will brief the Commission on State Water Project construction projects and provide an update from the State Climatologist on Water Year 2025.
