Commission staff will provide an update on the progress of projects in the Water Storage Investment Program (WSIP), including an update on Valley Water Board's decision to suspend pursuit of the Pacheco Project.

Representatives of the Sites Project will present their request for early funding to the Commission. The Commission will decide whether to award early funding to the project and the amount of early funding.

12. Best Practices in Meaningful Tribal Engagement and Consultation

Representatives of DWR's Office of Tribal Affairs will provide an overview of current State policies mandating Tribal consultation and Tribal engagement with California Tribes and how the current application of State policies can be implemented to achieve meaningful engagement with Tribes.
