Purpose:

- 2) Continue to advance planning activities for successful completion of required permitting and project approvals, including meeting regulatory standards for public participation.
- 3) Continue to refine the proposed project with regard to community benefits and impact minimization/mitigation development, based on public and stakeholder input.
