- If you select a community, it highlights the selection on the map and a pop up appears.
- Draws from filtered point layers



Layer List

There are 3 types of layers in the map. Each layer type has cities and counties layers.

- 1. NFIP boundaries polygon layers
 - These layers populate the NFIP Ordinance Status Charts
 - Select the three dots next to any layer to get the list shown to the left for more display options.



2. CRS Rating Layers

• These layers populate the CRS Rate Graphs



- 3. Filtered NFIP City and County FM Ordinance Adoption Status Points Layers.
 - These layers populate the FM Ordinance Adoption Counts summary.



Map Control Widgets

These widgets help navigate or customize the map.

Attribute Table Access

The arrow up button at the bottom of the map opens the attribute tables for the layers that are turned on in the map.

- The attribute table contains more fields than shown in the Pop Ups.
- There is a tab for each active layer's table.
- Double click any selected feature and the map will zoom to it.
- The table can be exported to a .csv file.
