Executive Committee Appoints Stakeholder Advisory Group and Adds Two Scientists to Blue Ribbon Citizen Commission

SACRAMENTO, Calif. – The Fish and Wildlife Strategic Vision Executive Committee today unanimously approved the Stakeholder Advisory Group and added two scientists to the Blue Ribbon Citizen Commission. The 52 members of the Stakeholder Advisory Group were selected from more than 130 applicants. The members were selected using the criteria and interest areas mandated by AB 2376 (Huffman). It was not possible to accommodate all those who were interested in serving and still keep the group to a workable size. To the extent possible, organizations were sought which represent coalitions of like-minded groups. All of the Stakeholder Advisory Group meetings will be open to the public in order to provide opportunities for direct input into the Fish and Wildlife Strategic Vision process. The final members of the group are listed below and on the strategic vision website.

The first meeting of the Stakeholder Advisory Group will be held Friday, Aug. 19 at 9:30 a.m. in the Resources Building Auditorium, 1416 Ninth Street, Sacramento, California 95814. Members are welcome to participate remotely via WebEx. The meeting agenda can be found here.

The Executive Committee also unanimously voted to appoint two science experts to the Blue Ribbon Citizen Commission.

David M. Graber, PhD, Chief Scientist, Pacific West Region, National Park Service (NPS)

Graber has devoted his career to assuring that policy and management are fully informed by the best scientific information. He works closely with agencies at all levels of government, private organizations, and academic institutions to further conservation of nature.

Skyli McAfee, Executive Director, California Ocean Science Trust (OST)

McAfee has spent her career in marine science at laboratories throughout the country. Prior to leading the OST, McAfee was at the University of California, Davis, Bodega Marine Laboratory, where she served as Assistant Director. In that capacity, she facilitated program development and administration of a renowned research lab engaged in multidisciplinary marine and terrestrial research, encouraging productive collaborations with federal and state partners such as the National Oceanic and Atmospheric Administration, U.S. Geological Survey, and California Department of Fish and Game.
