PROPOSITION 40

5096.610(a); 5096.615: Department of Parks and Recreation acquisition and development - \$225 million (Department of Parks and Recreation)

Eligible Recipients: State Park System.

Eligible Projects: Acquisition and development at state parks. Priority for visitor facilities and restoration projects. Not more than 50% for acquisition.

Note: Department of Parks and Recreation has over \$265 million in specific priority projects identified for this funding.

5096.610(b); 5096.620(a); 5096.621(a): Per capita grants to cities and districts - \$210 million (Department of Parks and Recreation)

Eligible Recipients: Cities, (non-regional) park districts and (non-regional) open space districts. Minimum allocation for cities and non-regional districts: \$220,000.

Eligible Projects: Acquisition, development, improvement, rehabilitation, restoration, enhancement and interpretation of local park and recreation lands and facilities.

Note: Ch. 322/02 requires the department to recommend grant recipients consider water conservation measures as part of bond funded projects.

5096.610(b); 5096.620(a); 5096.621(c): Per capita grants to counties and regional park districts - \$140 million (Department of Parks and Recreation)

Eligible Recipients: Counties, regional park districts and regional open space districts. Minimum allocation for counties and regional park districts: \$1,200,000.

Eligible Projects: Acquisition, development, improvement, rehabilitation, restoration, enhancement and interpretation of local park and recreation lands and facilities.

Note: Ch. 322/02 requires the department to recommend grant recipients consider water conservation measures as part of bond funded projects.

5096.610(b); 5096.620(b); 5628; 5629: Roberti-Z'berg-Harris (RZH): Block - \$166 million (Department of Parks and Recreation)

Eligible Recipients: Restricted to cities, counties and districts in urbanized areas. Non-competitive, based on population.

Eligible Projects: Acquisition, development, rehabilitation and restoration of park and recreation areas and facilities, or for innovative recreation programs and special major maintenance.

Note: Special Major Maintenance and/or Innovative Recreation Programs may not exceed 30% of grant funds. Ch. 322/02 requires the department to recommend grant recipients consider water conservation measures as part of bond funded projects. [Ch. 1031/02 and Ch. 240/03 Sec. 23 revised match requirement.]

5096.610(b); 5096.620(b); 5630(b): Roberti-Z'berg-Harris (RZH): Urban Need Basis - \$4.16 million (Department of Parks and Recreation)

Eligible Recipients: Restricted to cities and districts in urbanized areas that are not heavily urbanized. Need-based (always awarded competitively).

Eligible Projects: Acquisition, development, rehabilitation and restoration of park and recreation areas and facilities.

Note: Match requirement is 70/30. Ch. 322/02 requires the department to recommend grant recipients consider water conservation measures as part of bond funded projects. [Ch. 1031/02 and Ch. 240/03 Sec. 23 revised match requirement.]

5096.610(b); 5096.620(b); 5630(a): Roberti-Z'berg-Harris (RZH): Non-Urban Need Basis - \$29.84 million (Department of Parks and Recreation)

Eligible Recipients: Restricted to cities, counties and districts in non-urban areas (those who did not receive an RZH block grant). Need-based (always awarded competitively).

Eligible Projects: Acquisition, development, rehabilitation and restoration of park and recreation areas and facilities.

Note: Ch. 322/02 requires the department to recommend grant recipients consider water conservation measures as part of bond funded projects. [Ch. 1031/02 and Ch. 240/03 Sec. 23 revised match requirement.]

5096.610(b); 5096.620(c); 5096.621(g); reference 1: City with urban population over 350,000 in a county of the first class (City of Los Angeles) - \$12.5 million (Department of Parks and Recreation)

Eligible Recipients: City of Los Angeles.

Eligible Projects: Acquisition, development, improvement, rehabilitation, restoration, enhancement and interpretation of local park and recreation lands and facilities.

Note: Ch. 322/02 requires the department to recommend grant recipients consider water conservation measures as part of bond funded projects. Ch. 1126/02 Sec. 4(b)(2) specified the purposes for the project funds and appropriated them.

5096.610(b); 5096.620(c); 5096.621(g); reference 2: County of the first class. (County of Los Angeles) - \$10 million (Department of Parks and Recreation)

Eligible Recipients: County of Los Angeles.

Eligible Projects: Acquisition, development, improvement, rehabilitation, restoration, enhancement and interpretation of local park and recreation lands and facilities.

Note: Ch. 322/02 requires the department to recommend grant recipients consider water conservation measures as part of bond funded projects. Ch. 1126/02 Sec. 4(b)(2) specified the purposes for the project funds and appropriated them.

5096.610(b); 5096.620(d); 5096.625; 5643 (Ch. 876/01, Frommer) and Ch. 878/01, Burton: Urban Parks Initiative - \$140 million (Department of Parks and Recreation)

Eligible Recipients: Cities, counties, joint powers agencies, districts (other than schools) in heavily urbanized counties or cities over 100,000 population. Nonprofit organizations within these areas. Competitive.

Eligible Projects: Acquisition and development, or both, of property for new urban parks or new recreational or multipurpose facilities.

5096.610(b); 5096.620(d); 5096.625; 5004.5 (Ch. 877/01); Ch. 878/01: California Youth Soccer and Recreation Development Program - between \$0 and \$50 million (Department of Parks and Recreation)

Eligible Recipients: Local agencies and community-based organizations.
Competitive.

Eligible Projects: Development of new youth soccer, baseball and basketball facilities. Preference for those communities that provide matching funds and that are heavily populated, low-income urban areas with a high youth crime and unemployment rate.

Note: Total of \$50 million between this program and SUPHCA (see below): split not yet determined.

5096.610(b); 5096.620(d); 5096.625; 5095.5 (Ch. 877/01); Ch. 878/01: State Urban Parks and Healthy Communities Act (SUPHCA): Urbanized, heavily urbanized local agencies or community-based organizations - SUPHCA amount (\$0 - \$50 million) (Department of Parks and Recreation)

Eligible Recipients: State agencies (including existing state conservancies), urbanized or heavily urbanized local agencies and community-based organizations. Competitive.

Eligible Projects: Acquisition and development of properties for active recreational purposes.

Note: Total of \$50 million between this program and California Youth Soccer; split not yet determined.

5096.610(b); 5096.620(d); 5096.625 reference 1; 5098.348(b): Murray Hayden (Urban Youth Services) competitive - \$50 million (Department of Parks and Recreation)

Eligible Recipients: Heavily urbanized counties, heavily urbanized cities and nonprofit organizations or districts within heavily urbanized cities and counties. Competitive.

Eligible Projects: Parks, park facilities or environmental youth centers that (a) are within the immediate proximity of a neighborhood that has a critical lack of park or open space lands or deteriorated park facilities; (b) are in an area of significant poverty and unemployment; (c) have a shortage of youth services for youth. Priority shall be given to capital projects that employ neighborhood residents and at-risk youth.

Note: Ch. 1031/02 allows for a waiver of the local match requirement for these grants.

5096.610(b); 5096.620(d); 5096.625, reference 2: Central Park in City of Rancho Cucamonga - \$10 million (Department of Parks and Recreation)

Eligible Recipients: City of Rancho Cucamonga.

Eligible Projects: Development of Central Park.

Note: Ch. 1126/02 Sec. 4(b)(3) specified the purposes for the project funds and appropriated them.

5096.610(b); 5096.620(d); 5096.625, reference 3: City of LA for Hansen Dam - \$5 million (Department of Parks and Recreation)

Eligible Recipients: City of Los Angeles.

Eligible Projects: Park and recreation or community facilities at or adjacent to the Hansen Dam recreation area.

Note: Ch. 1126/02 Sec. 4(b)(4) specified the purposes for the project funds and appropriated them.

5096.610(b); 5096.620(d); 5096.625, reference 4: City of LA for Sepulveda Basin recreational parkland - \$5 million (Department of Parks and Recreation)

Eligible Recipients: City of Los Angeles.

Eligible Projects: For the Sepulveda Basin recreational parkland.

Note: Ch. 1126/02 Sec. 4(b)(5) specified the purposes for the project funds and appropriated them.

5096.650(a) - \$300 million (Wildlife Conservation Board)

Eligible Recipients: Federal, state and local governmental agencies, and nonprofit conservation organizations.

Eligible Projects: Acquisition, development, rehabilitation, restoration and protection of habitat that promotes the recovery of threatened and endangered species, that provides corridors linking separate habitat areas to prevent habitat fragmentation, and that protects significant natural landscapes and ecosystems such as old growth redwoods and oak woodlands and other significant habitat areas.

Note: These funds are continuously appropriated.

5096.650(b)(1) - \$200 million (State Coastal Conservancy)

Eligible Recipients: The State Coastal Conservancy, other public agencies and nonprofit organizations (e.g. land trusts).

Eligible Projects: Acquisition, restoration and enhancement of property in coastal areas; development of public access ways, including the coastal trail; enhancement of wetlands and other habitat areas; restoration of urban waterfront areas for public access and economic development; protection of agricultural lands; and restoration of watershed resources.

Note: These funds can be used to complete portions of the California Coastal Trail, which was the subject of a Governor's initiative pursuant to SB 908. The funds can also be used for the Southern California Wetlands Recovery Project. Urban waterfront projects can include a wide range of activities including development of facilities for the commercial fishing industry and for tourism.

5096.650(b)(2) - \$40 million (California Tahoe Conservancy)

Eligible Recipients: The California Tahoe Conservancy and other public agencies and nonprofit organizations (e.g., land trusts).

Eligible Projects: Acquisition and improvement of land (directly by the Tahoe Conservancy or through grants) for the purposes of preserving and restoring the natural environment (especially water quality), providing public access and recreation opportunities, and preserving wildlife habitat.

5096.650(b)(3) - \$40 million (Santa Monica Mountains Conservancy)

Eligible Recipients: Santa Monica Mountains Conservancy, cities, counties and park and recreation districts; nonprofit organizations.

Eligible Projects: Acquisition and development for park, recreation, conservation and open space purposes, and for restoration and resource enhancement by the Santa Monica Mountains Conservancy.

5096.650(b)(4): - \$20 million (Coachella Valley Mountains Conservancy)

Eligible Recipients: Coachella Valley Mountains Conservancy, cities, counties, resource conservation districts, or nonprofit organizations.

Eligible Projects: Direct acquisition and local assistance grants for the acquisition, development, rehabilitation, restoration and protection of lands within the boundaries of the Conservancy.

5096.650(b)(5) - \$25 million (San Joaquin River Conservancy)

Eligible Recipients: San Joaquin River Conservancy, federal, state and local public agencies and nonprofit organizations.

Eligible Projects: Acquisition, development, rehabilitation, restoration and protection of lands within the boundaries of the Conservancy.

5096.650(b)(6) - \$40 million (San Gabriel and Lower Los Angeles Rivers and Mountains Conservancy)

Eligible Recipients: San Gabriel and Lower Los Angeles Rivers and Mountains Conservancy, public agencies and nonprofit organizations.

Eligible Projects: Acquisition, development, rehabilitation, restoration and protection of open space, low impact recreational and educational uses, water conservation, watershed improvement, wildlife and habitat restoration and protection.

5096.650(b)(7) - \$40 million (Baldwin Hills Conservancy)

Eligible Recipients: Baldwin Hills Conservancy, local, state and federal public agencies and nonprofit organizations.

Eligible Projects: Land acquisition for the expansion of Kenneth Hahn State Recreation Area; park site planning, restoration and improvements; and develop public access and linkage to Ballona Creek.

5096.650(b)(8) San Francisco Bay Area Conservancy Program - \$40 million (State Coastal Conservancy)

Eligible Recipients: The State Coastal Conservancy, other public agencies and nonprofit organizations (e.g. land trusts).

Eligible Projects: Acquisition, restoration and enhancement of property in the nine county San Francisco Bay Area. Projects can include a wide range of activities, including development of public accessways and trails, enhancement and protection of wildlife habitat, development of regional recreational facilities and historic preservation. Funds can be used to acquire and protect agricultural and open space properties.

Note: These funds can be used to complete the San Francisco Bay Trail and the Bay Area Ridge Trail. The funds can also be used to implement wetland protection projects in furtherance of the San Francisco Bay Habitat Goals Project and the San Francisco Bay Joint Venture.

5096.650(c)(1) River Parkways - \$70 million (Secretary for Resources)

Eligible Recipients: Public agencies and nonprofit organizations

Eligible Projects: Acquisition and restoration of riparian and riverine habitat, river and stream trail projects and river parkways.

5096.650(c)(1) Urban Streams - \$5 million (Department of Water Resources)

Eligible Recipients: Local agencies and community groups jointly.

Eligible Projects: Urban stream restoration projects that reduce flooding and erosion and improve riparian areas.

5096.610(c); 5096.650(c)(2) Clean beaches, watershed protection and water quality projects - \$42.1 million (Undesignated)

Eligible Recipients: Public agencies and nonprofit organizations.

Eligible Projects: Clean beaches, watershed protection and water quality projects. Acquisition, development, restoration and associated planning, permitting and administrative costs.

5096.610(c); 5096.650(c)(2) Clean beaches, watershed protection and water quality projects: Clean Beaches Program - \$46 million (State Water Resources Control Board) (Ch. 727/02, Sec. 3(a)(1))

Eligible Recipients: Public agencies and nonprofit organizations.

Eligible Projects: Projects designed to improve water quality at public beaches and to make improvements to ensure that coastal waters adjacent to public beaches meet the bacteriological standards set forth in Article 2 (commencing with Section 115875) of Chapter 5 of Part 10 of Division 104 of the Health and Safety Code.

5096.610(c); 5096.650(c)(2) Clean beaches, watershed protection and water quality projects: Small Communities Wastewater Grant Program – \$15 million (State Water Resources Control Board) (Ch. 727/02, Sec. 3(a)(2))

Eligible Recipients: Small communities, defined as a municipality with a population of 20,000 persons or less, a rural county or a reasonably isolated and divisible segment of a larger municipality where the segment of the population is 20,000 persons or less, with a financial hardship, as determined by the State Water Resources Control Board.

Eligible Projects: Publicly-owned wastewater treatment facilities.

5096.610(c); 5096.650(c)(2) Clean beaches, watershed protection and water quality projects: Urban Storm Water Grant Program - \$15 million (State Water Resources Control Board) (Ch. 727/02, Sec. 3(a)(3))

Eligible Recipients: Public agencies.

Eligible Projects: Projects designed to implement storm water runoff pollution reduction and prevention programs, including, but not limited to, diversion of dry weather flows to publicly owned treatment works for treatment, acquisition and development of constructed wetlands and the implementation of approved best management practices, as required by storm water permits issued by the State Water Resources Control Board or a regional board.

5096.610(c); 5096.650(c)(2): Clean beaches, watershed protection and water quality projects: Nonpoint Source Pollution Control Program - \$20 million (State Water Resources Control Board) (Ch. 727/02, Sec. 3(a)(4))

Eligible Recipients: Local public agencies and nonprofit organizations.

Eligible Projects: Projects that protect the beneficial uses of water throughout the state through the control of nonpoint source pollution.

5096.610(c); 5096.650(c)(2): Clean beaches, watershed protection and water quality projects: Agricultural Water Quality Grant Program - \$12 million (State Water Resources Control Board) (Ch. 727/02, Sec. 3(a)(5))

Eligible Recipients: Public agencies and nonprofit organizations.

Eligible Projects: Projects that improve agricultural water quality through monitoring, demonstration projects, research, construction of agricultural drainage improvements, and projects to reduce

pollutants in agricultural drainage water through reuse, integrated management or treatment.

5096.610(c); 5096.650(c)(2) Clean beaches, watershed protection and water quality projects: Small Communities Ground Water Grants - \$10 million (State Water Resources Control Board) (Ch. 727/02, Sec. 3(a)(6))

Eligible Recipients: Local public agencies and not-for-profit water companies that serve small communities, where small community is defined as a municipality with a population of 20,000 persons or less, a rural county, or a reasonably isolated and divisible segment of a larger municipality where the segment of the population is 20,000 persons or less, with a financial hardship, as determined by the State Water Resources Control Board.

Eligible Projects: Projects that assist small communities in complying with groundwater contaminant level requirements in drinking water supplies. Priority will be given to projects that address arsenic or nitrate.

5096.610(c); 5096.650(c)(2) Clean beaches, watershed protection and water quality projects: Integrated Watershed Management - \$57 million (State Water Resources Control Board) (Ch. 727/02, Sec. 3(a)(7))

Eligible Recipients: Public agencies and nonprofit organizations.

Eligible Projects: Watershed protection and water management projects that include one or more of the following elements:

- (1) Storm water capture and treatment.
- (2) Nonpoint source pollution reduction, management and monitoring.
- (3) Groundwater recharge and management projects.
- (4) Water banking, exchange and reclamation, and improvement of water quality.
- (5) Vegetation management to improve watershed efficiency, aquatic and terrestrial habitat, the creation and enhancement of wetlands, and the acquisition, protection and restoration of open space.
- (6) Planning and implementation of multipurpose flood control programs that protect property and improve water quality and storm water capture and percolation, and protect or improve wildlife habitat.
- (7) Demonstration projects to develop new water treatment distribution and nonpoint source pollution control methods.
- (8) Erosion sediment control and stream enhancement projects, and permit coordination programs to facilitate

watershed restoration projects that implement board-approved management measures for polluted runoff.
(9) Native fisheries enhancement or improvement projects, and projects to restore other threatened species.

5096.650(c)(2): Clean beaches, watershed protection and water quality projects: Integrated Watershed Management - \$46.4 million (State Coastal Conservancy) (Ch. 727/02)

Eligible Recipients: State Coastal Conservancy, public agencies and nonprofit organizations.

Eligible Projects: Watershed protection and water quality projects. Acquisition, development, restoration and associated planning, permitting and administrative costs.

5096.650(c)(2) Fisheries Restoration Grant Program - \$24 million (Department of Fish and Game)

Eligible Recipients: Public agencies, nonprofit organizations, private enterprises and Indian tribes.

Eligible Projects: Watershed protection and restoration, salmon and steelhead trout conservation and habitat restoration, including acquisition and development. Fish ladder, instream barrier modification, instream habitat restoration, riparian restoration, instream bank stabilization, watershed restoration (upslope), fish screening of diversions, tailwater management, water conservation measures (ditch lining, piping, stock water systems), water measuring devices (instream and water diversion) and water purchase.

5096.650(c)(2) Forest Resource Improvement Projects - \$2 million (Department of Forestry and Fire Protection)

Eligible Recipients: Non-industrial forest landowners that own between 20 and 5,000 acres of "forestland" in California. Landowners that own less than 20 acres may qualify if they submit a joint application with neighboring landowners and the combined acreage is a minimum of 20 contiguous acres of forestland.

Eligible Projects: Management plan, registered professional forester supervision, site preparation, trees and planting. Tree shelters, pre-commercial thinning, pruning, follow-up, release, land conservation/wildlife/fisheries projects.

5096.650(d) Air Quality - \$50 million (Air Resources Board)

Eligible Recipients: California air quality management or air pollution control districts.

Eligible Projects: Projects that meet the eligibility criteria of the Carl Moyer Memorial Air Quality Standards Attainment Program and the Lower-Emission School Bus Program for the purpose of affecting air quality in state and local parks and recreation areas.

Note: A minimum of \$200,000 is available as grants for each district.

5096.650(e)(1) Resource Conservation Projects - \$5 million (California Conservation Corps)

Eligible Recipients: California Conservation Corps.

Eligible Projects: Resource conservation projects.

5096.650(e)(2) Local California Conservation Corps Grants - \$15 million (California Conservation Corps)

Eligible Recipients: Local Conservation Corps.

Eligible Projects: Acquisition and development of facilities to support Local Conservation Corps programs.

5096.650(f) Agricultural and Grazing Lands - \$8.375 million (undesignated)

Eligible Recipients: State agencies; other eligible recipients dependent upon nature of the appropriation.

Eligible Projects: Preservation of agricultural lands and grazing lands, including oak woodlands and grasslands.

5096.650(f) Oak Woodland - \$4.8 million (Wildlife Conservation Board) (Ch. 983/02)

Eligible Recipients: Federal, state and local governmental agencies, nonprofit conservation organizations and private land owners.

Eligible Projects: Oak woodlands conservation easements, land improvement, cost-sharing incentive payments to private landowners, public education and outreach, and assistance in the development of local general plans relative to oak woodland habitat.

5096.650(f) – California Farmland Conservancy Program - \$40 million (Department of Conservation)

5096.610(d); 5096.652(a): Historical and Cultural Resources – \$91.643 million (Department of Parks and Recreation – DPR) (Ch. 1126/02)

Eligible Recipients: Public agencies or nonprofits.

Eligible Projects: Acquisition, development, preservation, or interpretation or any combination thereof buildings, structures, sites, places or artifacts, or any combination thereof, that preserve and demonstrate culturally significant aspects of California history.

5096.610(d); 5096.652(a): Historical and Cultural Resources - \$128.4 million - California Cultural and Historical Endowment within the California State Library (Ch. 1126/02)

Eligible Recipients: Public agencies, nonprofits and tribal organizations.

Eligible Projects: Preserve and demonstrate:

- (1) Culturally significant aspects of life during various periods of California history, including architecture, economic activities, art, recreation and transportation;
- (2) Unique identifiable ethnic and other communities that have added significant elements to California's culture;
- (3) California industrial, commercial and military history, including the industries, technologies and commercial activities that have characterized California's economic expansion and California's contribution to national defense;
- (4) Important paleontologic, oceanographic and geologic sites and specimens; and
- (5) The archaeology, history or culture of California's Native American population.

5096.610(d); 5096.652(b): City park of historical and cultural significance that is over 1,000 acres and that serves an urban area with a population that is greater than 750,000 in Northern California (Golden Gate Park) – \$35 million (unspecified agency)

Eligible Recipients: San Francisco

Eligible Projects: Development, rehabilitation, preservation, restoration and interpretation of resources at Golden Gate Park.

Eligible Projects El Pueblo Cultural and Performing Arts Center.
