The Groundwater Sustainability Agency (GSA) Forum is a series established by DWR to provide a consistent venue for GSA members and interested parties to engage in conversation and exchange ideas around topics related to Groundwater Sustainability Plan (GSP) implementation. The theme for the Fall Forum was *Well Management Approaches: from Enhancing Local Understanding to Leveraging Local Coordination*. The event included a panel discussion highlighting how GSAs are addressing well management topics such as well inventory programs and registrations, implementation of Senate Bill 552, and well permitting approaches. Panel members represented the County of Napa GSA, County of Madera GSA, McMullin Area GSA, and Sonoma County GSAs. The program also included an opportunity for attendees to share experiences and resources through a breakout session, and spotlighted upcoming Department efforts and resources that support well management.
